### 3 – HISTORY

# "But whoever has the world's goods and sees his brother in need and close your heart, how can the love of God remain in him?". I John 3:17



In 1966, coming from Stadskanaal – The Netherlands, the Dutch couple missionaries, Nicolaas and Trijnie van Eijk arrives in Brazil. After spending a year working in an institution in São José do Rio Pardo - São Paulo, the couple moved in 1967 to the small town of Sabinópolis, located in the central-northestern Minas Gerais.

In 1968, they founded the Missionary Evangelical Pentecostal Church (IEMP), and through contact with the numerous social problems in the community, came the realization that the gospel should be presented through the loving care to the needy. The couple begins to serve children and families in their own residence. The biblical message of I John 3: 17 challenges the couple and their Dutch brothers to act on the community's social situation, it was large number of unstructured poor and the malnourished children who wandered begging in the city streets.

Thus, in 1973, it founded the BEM - Well Being of Minors, legal personality body and diaconal arm of IEMP to meet the social needs of children, families and communities in a institutional way. Since then, projects and actions that have been developed over the years have contributed significantly to meeting the needs, the transformation and social development of the communities where the BEM has expanded, as in the mining towns of Sabinópolis, Materlândia, Rio Vermelho, São Paulo, Carmésia, Senhora do Porto e Vera Cruz, in the state of Bahia.

Currently, the missionary couple resides in Belo Horizonte and still actively participates as a volunteer in the activities of Widow Fellowship Center (VEM) project. Since their retirement, the couple serves as director of the board BEM. The most significant efforts of the missionaries, however, regards the leadership of IEMP church in BH by collaboration and travel arrangements for social work in the villages where BEM is present.

# 6 - LOCATION

The BEM is present in seven municipalities in the Northeast Center, Vale do Rio Doce, Mucuri and Jequitinhonha, in Minas Gerais, and in Vera Cruz, municipality of Bahia, in the coastal region, Itaparica Island.



#### 7- EDUCATION

"Education aims at the full development of the student, their preparation in the exercise of citizenship and his qualification for work. It is the right of all and duty of the family and condition. The development in family life, community, work, social movements, civil society organizations, cultural events contribute to the education and training process. " 1988 Brazilian Constitution

#### 7.1- Child Care Center: Early Childhood Promotion



Law of Guidelines and Bases of National Education (LDB - Law No. 9.394 / 96) introduces a serie of inovations related to Education, among those: the reintegration of creches in the system, composing, together with the preschools, the first stage of Basic Education. This law evidences the encouragement of the autonomy of educational units in the flexible organization of

their curriculum and the plurality of pedagogical methods, as long as they ensure learning and reaffirm the articles of the Federal Constitution regarding free attendance in kindergartens and pre-schools.

Infantile Education aims at the integral development of children from zero to five years of age in their physical, affective, intellectual, linguistic and social aspects, complementing the action of the family and the community (Law n° 9.394 / 96, article 29).

BEM day care centers, created since 1974, offer protection and social rights advocacy for children and their families. They attend the period from 07 am to 4 pm from Monday to Friday, following the guidelines of the National Curriculum Parameters of Early Childhood Education (PCNEI). Its accreditation and functioning authorized by the State Board of Education (CEE-MG), since 2002, following the current legislation, working in the age group from 06 months to 03 years and 11 months.

In 2016, **359 children** from 06 months to 47 months of age (170 boys and 189 girls) were attended in 08 units: Sabinópolis Sede - 74; Euxenite-23; Materland - 42; Rio Vermelho - 55; Paulistas - 42; Senhora do Porto - 29; Carmésia - 54 all of them in Minas Gerais and Vera Cruz - Mar Grande, has 40 children in Bahia.

BEM counts on the maintenance of daycare centers with public resources from FUNDEB (MEC), Programa Brasil Carinhoso (MDS) and National School Feeding Program (PNAE), through agreements with municipalities.

#### 7.2 Pedagogical Proposal

The Pedagogical Political Project - PPP understands the child as a complete being and sees education as an ongoing process for development, generating social, economic, political transformations and enabling the acquisition of autonomy in early childhood.

Above all, the project presents play and interact as guiding axes of the methodology of work with children attended by the daycare center. Through sounds, speech, gestures and playful activities that experiences are generated, interrelationships strengthened, and in a delicious way, the children's imagination is nurtured.

In addition to the routine activities (bathing, food and rest), various activities of leisure, sports, arts, oral and written language, activities of logical capacity, scientific curiosity and socialization were carried out to stimulate the development of different skills. Activities of theater, walks, celebration of birthdays, bath of swimming pool, demonstrations and rallies, campaigns, mutirão of prayer, special celebrations and pedagogic interventions.

BEM seeks to respond to the local need arising in the dialogue with families, community and authorities, aiming at expanding the promotion and defense of children's rights in access to education and health and the integral development of citizenship and full life.

Engaging families in the lives of children in daycare has been one of the goals that make the family's affective and protective role stronger. Thus, about 333 families participated in various activities of the projects and events of coexistence and celebration throughout 2016. The families also participate in an annual evaluation that aims to signal weaknesses and strengths of the educational process and consequently, the growth and development of the assisted children in daycare centers. Right above, there is a quantitative framework for a better understanding of the work of the Creche.

#### 9.0 SOCIAL ASSISTANCE

Social protection policy guarantees meeting the basic needs of families and individuals in vulnerable situations. The social assistance rights follow the principles and guidelines of the National Policy and Unified Social Assistance and ITS-Basic and Special Protection Services.

#### 8.1- Development & Empowerment Promotion of Communities

From the Federal Constitution of 1988, the Brazilian society has made progress towards the realization of social rights, highlighting the transformation of Social Assistance that has been elevated to the level of citizen's right and State duty, integrating it to Social Security. In order to implement this principle of law was built from extensive social mobilization, the Organic Law of Social Assistance - LOAS 8,742 / 1993, which defines national standards regarding social assistance, as well as the performance of civil society. In 2004, the National Council of Social Assistance (CNAS), through resolution, deliberated on the current National Social Assistance Policy (PNAS), with the objective of consolidating the rights and its regulations to implement the Single Social Assistance System / SUAS occurred in the year of 2011 with Law 12.435 that emphasizes the parameters for regulation and organization of the entities in the area of social assistance and their socio-welfare actions throughout the national territory.

In this perspective, BEM provides free, ongoing, permanent and planned assistance to families and individuals in situations of vulnerability and social risk due to poverty and exclusion in the cities of Rio Vermelho, Materlândia, Sabinópolis, Paulistas, Carmésia, Senhora do Porto - Minas Gerais and Vera Cruz / BA. The organization promotes the development of communities through the advice, autonomy, defense and guarantee of users' rights in participatory processes through its social programs and projects. By goal, there is the promotion of communities in a participatory, integrated, environmentally and socially sustainable way with community leaders empowered to work in an articulated way with the various public and private social actors.

Thus, in the following lines, follows the description of the programs and actions developed by BEM in the area of social assistance.

#### 8.2 - Community Centers:



It is a strategic physical space located in vulnerable communities in order to contribute to family strengthening and integration in community development purposes with participation in groups in which their rights of citizenship are fully promoted through the care of families, individuals, child

and teenager. Within the Single System of Social Assistance - SUAS, it is in line with the "defense and realization of social assistance rights, construction of new rights, promotion of citizenship, coping with social inequalities, articulation with public agencies for the defense of rights, addressed to the public of the Social Assistance Policy<sup>1</sup> :being, therefore, a useful equipment for the development of community in the localities that are present.

BEM currently has two Community Centers, one located in the municipality of Sabinópolis-Mg, Nova Pousada Community Center and Rio Vermelho Community Center-MG.

In the year 2016, these centers developed several activities for family strengthening, protection, defense and guarantee of the rights of children and adolescents, community development, work and income. A total of **259 families** were assisted in the various activities of the BEM Community Centers:

#### 8.3 – BEM Kids Fellowship



Its objective is to promote citizenship, strengthen family and community ties, and prevent the violation of the rights of children aged between 4 and 11 years who experience situations of vulnerability and / or social and personal risk. It is developed in Community Centers and other BEM facilities. The differential of this project is that it allows the attendance of groups of siblings,

allowing the narrowing and strengthening of affective bonds. Considering also that the leisure options in the locality are scarce, children have the opportunity to develop their skills. They can have support of the social agents before or after school activities. The program also offers space for socializing for children to develop their protagonist and autonomy potential for life in family and community in accordance with the guidelines of the Service of Coexistence and Strengthening of Bonds.

The activities carried out in the facilities of the Community Centers occur twice a week in counter periods, and the activities carried out in the BEM daycare centers take place on a daily basis, with similar activities in the form of a workshop. In the localities of Carmésia, Materlândia and Sabinópolis the program counts on the partnership of the municipality.

In all the locations where Kids Fellowship is present, are offered: Christian ethics workshops, films, gymnastics, toy room, library; activities guided by relevant themes, considering the interests and demands, abilities and potentialities, always based on ludic, cultural and sports experiences, with a view to strengthening family and community ties through joint actions with the protection network. Portuguese, mathematics, environment preservation and healthy sexuality workshops are also developed.

Among the results achieved by the project, the following improvements must be highlighted: Self-esteem by valuing their work and rural culture; Income per capita of the family; Quality products offer; Municipal agriculture policy, giving visibility to the community and participatory work with the introduction of new cultures and eating habits; Development of the local economy; Emergence of local leaders; Family and social relationships.

#### 8.5 - Connected



It's a supportative action that aims to value children and adolescents (7 to 17 years old) by developing activities that meet the needs of this public on counter-school-shift. It happens in partnership with the Service of Coexistence and Strengthening of Links - SCFV of the municipality of Sabinópolis. **180 children and adolescents** participated in the service in the headquarters (130 children and adolescents) and in the district of Euxenita (50 children and adolescents). They also happened to the public with

disabilities in partnership with APAE-Sabinópolis.

The SCFV offers workshops in painting, music, crafts and computer science, access to the library, theater, dances, walks and meetings of groups of friends, as well as the development of environment and healthy relationships, family and community living.

#### 8.6 - Casa Laranja (Orange House)



It's a Special Social Protection Sheltering Service with capacity for 10 children from 0 to 12 years old. Throughout 2016, a total of 21 children, residents of the municipality of Rio Vermelho, were attended. They left the house after a court decision. 08 children referred for family reintegration of origin or extended, provisional custody or adoption. In

December, 05 children and 06 adolescents with family approach actions awaiting referrals from the judiciary, currently totaling 11 individuals, remain in the reception service. The children and adolescents are cared for daily and referred to the education, health and social services of the municipality. Systematic hearings are held by the judiciary along with the network of protection of children and adolescents. In these opportunities, there are discussions of cases and decisions regarding the progress and processes of each child.

The social approach is made by the technical team to the families to improve the bonds, parental skills and possible resumption of care with the children and finally, the return of the children to the care of the family.

#### 8.7- CLAVES – Playing, we get ourselves strongers for facing difficult situations

# claves

Program for the prevention of child abuse and sexual violence in childhood and adolescence, as well as the promotion of good family relationships. Through sequential workshops, Claves provides a playful

and participatory approach, which promotes the reduction of vulnerabilities of children and adolescents through the development of personal, family and community strengthening factors. Songs, dances, board games, theatrical games, stories, puppets, divinations, puzzles and other techniques are explored in the workshops.

In 2016, workshops were given to **366 children and adolescents**, of whom 195 were children from 04 to 06 years of age; 129 children aged 7 to 11 years; And 42 adolescents. The 23 classes of children and adolescents participated in 185 sequential workshops with 22 educators trained for CLAVES methodology.

The CLAVES Brasil / BEM partnership ministered in 03 courses: "Playing in the Strength to Confront Difficult Situations"; Araçuaí-MG; Bragança Paulista-SP; Itabira-MG with a total of 95 educators, technicians and leaders trained to use the methodology with children and adolescents of their communities and projects. The course "Good Family Treatment", workshop with facilitators who work with family groups to develop skills in the relationship of care among its members. Participants were 74 educators and leaders in Sabinópolis and Rio Vermelho in Minas Gerais. There was also participation in the 20-year Latin American Meeting of the CLAVES Program in Antigua-Guatemala (28/08 to 01/09 of 2016). For more information: http://www.clavesbrasil.com.br/.

# **8.8-Family Action** Protection & Prevention of Mistreatment



It aims to strengthen the family in its preventive and protective function, providing space and support to improve the quality of life and access and orientation to the rights of care partners. The families referenced in all BEM programs, approximately 820 families receive assistance from staff of social agents, educators and project managers, through home visits, interviews,

counseling, referrals and attending systematic family meetings and events such as: Parents in the Project "and" Family Party ", meetings with families, groups of mothers, family coexistence. There were 81 actions in the family groups throughout 2016 through BEM programs and strategies.

### 8- RIGHTS PROMOTION & ADVOCACY

### 9.1- Consultancy<sup>2</sup>: Technicl Support, Network Articulation and Following-up

They consist of actions aimed at the promotion and defense of socio rights, promoting active citizenship through participation in public policy councils, community groups, campaigns, events, meetings and networks that constitute BEM's defense and legal rights actions.

BEM works to strengthen and promote the defense of the rights of its participants through training, counseling, facilitation of leadership and development and community potential that contribute to the organization, autonomy and protagonism of users, families, councils and communities.

### 9.2- Children & Adolescents Prevention and Protection Policy - PPCA

It is a Protection Policy for Children and Adolescents (PPCA) that has been built collectively by the social agents involved in BEM services, programs and projects. The document aims to generate an institutional strategy based on nationally and internationally established standards to

offer safety and protection to children and adolescents participating in the social projects developed by BEM.

In implementing the PPCA, BEM wants children and adolescents to be protected according to a standard of practices that keeps them safe and protected.

#### 9.3- Public Policies Municipality Councils

Approximately 73 BEM representatives participated as Municipal Councilors in some 45 Councils and Commissions for articulating public policies in seven municipalities where BEM operates in the states of Minas Gerais and Bahia. These contributions aimed to achieve social control and development of public social policies. It contributed to the supervision and quality of services provided as well as to the citizen participation that allows listening, meeting local needs and demands.

These actions included mobilizing and strengthening networks through discussions of specific themes, capacities, new projects and approximation with various public, legislative, executive and judicial authorities, greater awareness and organization of citizen rights and the fight against violations Rights.

BEM's social agents team participated in 56 council meetings (forums, meetings, conferences) in the municipalities of Sabinópolis, Materlândia, Rio Vermelho, Paulistas, Senhora do Porto, Carmésia and Vera Cruz: Social Assistance, Children's Rights and Adolescent, School Feeding, Health, Sustainable Rural Development, Senior Citizen, School Collegiate.

#### 9- PARTNERSHIPS

**Rede Mãos Dadas (Holding Hands Network):** It is composed of 26 national and international partners whose goal is to strengthen actions aimed at promoting a dignified life for children and adolescents in social vulnerability who have their rights guaranteed and exercise their citizenship in an integral manner. RMD produces Revista Mãos Dadas to publicize its actions and support those who work for the dignity of children and adolescents. The IEMP / BEM in Belo Horizonte hosted the Annual Meeting of the Mãos Dadas Network on 31/06 and 01/07 with the participation of 150 people from various partner entities. They represented BEM / IEMP, 12 leaders and educators from 12 projects. For more information, visit: http://www.redemaosdadas.org/.

**20th Prayer Taskforce - Rede Mãos Dadas** (5th to 7th of June) - International annual mobilization of prayer and intercession for children and adolescents at risk with the theme: "Jesus present in each

child's childhood". Approximately 808 children and adolescents and 85 adults participated in the BEM programs and projects.

**Social Educator Campaing** (17<sup>th</sup> of September) - With recognition and actions performed among BEM's 95 social agents. Participants also included social partners of project partners and counselors of municipal councils. It was up to the local IEMP churches to conduct the Campaign.

**Sociedade Bíblica do Brasil (Brazililian Biblical Society) -** Through SBB, significant and quality publications were distributed to families, children and adolescents. Support material for social educators and community facilitators in the development of Christian values and prevention of situations of domestic and community violence. All material presents excellent quality and invaluable value in sharing biblical values. Written literature contributes to the educational and cultural development of the citizens of the communities and with the social, emotional and spiritual support of families, children and young people.

**May, 18th Campaing** - Prevention of Sexual Abuse in Children and Adolescents. Every year, on this date, BEM participates in marches along the protection network in the municipalities of Rio Vermelho, Sabinópolis, Materlândia, Carmésia. It was also promoted an action with all the members of the protective network in Sabinópolis to bring awareness of how kids must be protected against sexual abuse.

#### **10.1- Interactions with Public Policies**

In each municipality, BEM has developed a productive dialogue and joint actions in particular with the Secretariats of Health, Social Assistance and Education.

The most prevalent programs were in the area of health, such as were preventive action against obesity and malnutrition, oral health, nutrition, weight control and development, domestic accidents, defense and guarantee of the rights of children and adolescents, medical services of pediatrics, articulation for peace and family agriculture.

Through FUNDEB and the National School Feeding Program (PNAE), funds are made for daycare centers. We also obtained Agreements with City Halls for the execution of the Services of Coexistence and Strengthening of Links - SCFV.

There were also contacts with the judiciary of the municipalities of Sabinópolis, Rio Vermelho and Carmésia to receive funds from pecuniary benefits.

#### **10.2- Socio-Educative Measures & Community Work**

They were sent by the judiciary to BEM, with execution in the Creche de Paulistas, 02 adults, to fulfill Community Service Provision, where they developed general services activity with an average duration of 20 hours per week for one per period of six months, and the other, for a month.

#### 10.3- VEM – Widows with a Mission



VEM / IEMP, in partnership with BEM Belo Horizonte in 2016, sought to promote the socialization of women through socio-cultural activities, contributing to the improvement of the quality of life in spiritual, social and cultural areas. Life with God, with the next and to corroborate so that a circle of friendships and mutual support was formed.

VEM located in the city of Belo Horizonte

developed systematic activities, registered 90 meetings, counting on the participation of 50 mullheres, of these, 30 come regularly and participate in the proposed activities, with application of reflections, jokes, lectures with themes related to the challenges Of the third age, annual camp, bimonthly newsletter sent to each participant, home visits. The monthly meeting was held, with a duration of two hours, with an average of 60 participants.

VEM also provided special assistance for the elderly. They were occasionally attended: physically debilitated, demented (semidependent) people, at the onset of alzhiemer disease, these, when still in condition to participate in group activities, and the elderly with a diagnosis of depression. There were also (09) nine volunteers. The physical space used is provided by the Evangelical Pentecostal Missionary Church in Belo Horizonte.

The VEM of Sabinópolis developed its activities in a space provided by BEM with the participation of 27 elderly women, totaling 96 appointments, 12 monthly meetings with an average duration of 2h in 2016. Home visits were carried out, when necessary. To carry out this program, we counted on (02) two volunteers.

#### 10- HEALTH: Promotion of Health, Food and Nutritional Security

Adequate food is a fundamental human right. Food and Nutrition Security consists of the right of regular and permanent access to quality food, in sufficient quantity, for the promotion of health and that are environmentally, culturally, economically and socially sustainable.

BEM promotes the organic production of food that is served to about 695 children in the programs of Daycare and Kids Fellowship. The provision of daily meals that contribute to the growth, development and formation of healthy eating and nutritional habits. To do so, it uses standards and guidelines of the PNAE - National School Feeding Program and the orientation of nutritionists, being offered for these programs the number of 254,764 complete meals and snacks.

For the public served at the Nova Pousada Community Center and Rio Vermelho Community Center, approximately 9,837 complete meals and snacks were provided.

With the implementation of a dental office at the Nova Pousada Community Center in Sabinópolis, about 05 people were seen in 08 visits until December 2016, with the children of the community as a priority public, since this group has difficulty finding vacancies in the community. Public health network.

#### **12- COMPLEMENTARY ACTIONS**

In addition to direct assistance to project beneficiaries, BEM carries out activities aimed at strengthening and improving its work teams. There is an offer of alternative spaces for the projects, beneficiaries and community, besides the involvement and participation of volunteers.

#### 12.1- Bereia Conference Center - CCB

Support place for sports and leisure events, training, socialization, camps, congresses, meetings of groups linked to BEM. The space is also open to churches, prefectures, projects and schools. It serves both the public of Sabinópolis and the entire region. The CCB received in 2016 a total of 3,424 people in 37 events with the participation of young people (163), children (683) and adults (867).

Among the activities developed at the CCB are weddings, sporting and leisure events, anniversaries, graduation, camping, training, conferences, baptisms of churches and lodging.

#### **12.2- BEM Ranches Production**

BEM produces vegetable gardens, legumes and fruits in the areas of planting distributed in: Farms Bethel, Bereia and Belem in Sabinópolis, and Beersheba Farm, in the district of Euxenita -Sabinópolis. In the year 2016, 9,497.9 kg of legumes and 10,950.9 sauces and 9,385 kg of fruits of the season were harvested in these supradite locations.

#### 12.3- Volunteers

BEM develops actions for recruitment and management for volunteers who offer their time, ability and solidarity in varied services to the community. There are several volunteer fronts. The presence and voluntary contributions of families that participate in the projects stand out.

In 2016, 662 people volunteered in activities such as: Craft workshops, music, recreation and sports, agricultural technicians, drivers, general services, psychologists and physiotherapists, counselors, lecturers, attendance and programs with families.
